

Annual Report 2012-13, Abhoy Mission Brief Introduction of the Projects / Programmes

<u>'Abhoy Ashram' - Rehabilitation Centre for Senior Citizen (Old Age Home)</u>

Joint family system disappearing gradually, the older people are not given proper care of in absence of the family-members, busy otherwise by this way or that. Hence, to provide basic amenities in order to upgrade the life-style of the older people up to a reasonable state, Ministry of Social Justice & Empowerment, Govt. of India, have launched a scheme titled "Integrated Programme for Older Persons".



We have set up a Rehabilitation Centre (Old Age Home) in the year 1993 for providing social security in all respect to the older persons, lone aged persons of the family having no means of livelihood, are left careless and shelter less in the society. Presently there are 25 inmates come from all over the State in the Home who are being looked after round the clock by a team of specially trained staff from National Institute of Social Defence. They have been given the opportunity to communicate their views to each other which helped them develop a family manner and social bonding. The following services are provided from our end:-

- Crisis Care (during emergencies).
- Home Support Service through NISD trained caregivers.
- Short Stay facilities for aged people in emergency (Open to all).

Homely Facilities for Residents with congenial environment-

- Appropriate Health care.
- Nutrition maintaining food value and taste.
- Vocational therapy, counseling & training.
- Physiotherapy & Occupational therapy
- Library facility
- Recreational facility
- Games & Sports.
- 24 X 7 Hours Ambulance Facility to meet unforeseen incidents.
- Solar Hot Water plant, Generator & Solar Lighting System also available.

Help Line and Counseling Centre: -

In order to provide Help Line round the clock to those people and their relatives who are facing inconveniences due to some communication gap with the children or nearest ones. At times, such information gap leads to domestic violence with senior citizens and many other unforeseen situations such as: serious illness, despair due to loneliness, uncalled for awkward interactions leading to violence within the family etc. In such cases, they can make telephonic communication at any moment with us using 0381-21338607, 919436123069 phone numbers, or e-mail – <u>abhoymission@rediffmail.com</u>. In case of security question, we provide them Doctor, Physiotherapist, care giver, food, health, protection and necessary aid wherever necessary including Ambulance Facilities. Counseling and advocacy on behalf of the client within the family and community is also taken up wherever necessary including police, assistance etc. to demonstrate a peaceful atmosphere devoid of domestic violence.

Residential Care Institute for Mentally Retarded, Cerebral Palsy, Autistic and Multiple Disabled under SAMARTH project.

Abhoy Ashram complex, Gokulnagar under Bishalgarh Sub- Division.

Samarth project provide permanent care to abandoned and destitute children, support and protection to persons whose family support gradually fall short of circumstances. Provided need based services to young Persons with Mental Retardation, Cerebral Palsy, Autism and Multiple Disabilities who need to stay in group homes and independent living situations and Seniors Citizens with disabilities. Barrier-free Toilets, Bathrooms, Dining Hall, Bed-rooms are built keeping their frequent movement and comfort in view. The following services are being provided:

- Care Service.
- Weekend Respite Service
- Overnight and Extended Night Stay under J.J. Act.
- Crisis Care (during emergencies)
- Independent Living for Young Adults.
- Home Support Service.

Lessons are imparted to help the beneficiaries get the opportunity to learn to live more independently as well as to develop self-confidence, communication skills, Social skills and independent living skills. They are encouraged in art culture and craft, games & sports etc.

Community Based Rehabilitation under SaGP project, Help Age India.

It was felt necessary to provide need based family support to the aged people, living within the families. It was noticed that the aged people were not duly paid attention to their necessities, requirements and other needs by the family members due to some financial and other reasons. In such cases, Help Age India have extended their support through Sponsor a Grand Parent Programme (SaGP) from 2003 to us in order to render our help and assistance to ensure community based rehabilitation of those needy people. Naturally, under (SaGP) Project, the system of providing Food grains, clothes & garments, mosquito nets, pocket money, medicines etc. to 50 aged



grandparents, is continuing on the basis of consultation and requirements of the beneficiaries. So, the security and care & protection of the older persons are ensured under SaGP Project.

CHILDREN HOME FOR ORPHAN WITH SPECIAL NEEDS

Abhoy Mission is running a Children Home 'Swabalamban Rehabilitation Centre' with 50 seat capacity for the orphan children with special needs and Street Children or the children whose parents are unable to maintain them. The home is certified or registered with the Govt. of Tripura, Directorate of Social Welfare & Social Education vide registration No. 03/13 under Juvenile Justice (Care & Protection of Children) Act. 2000 subsequently amended in 2006. Eligibility for admission to this home is from 0 - 18 years for girls and below 10 years for boys. This home runs as per



guideline of Integrated Child Protection Scheme (ICPS) under Ministry of Women and Child Development, Govt. of India. Presently, 30 Children are residing in this home.

- Two Community Coaches Training under MYAS was organized by the Special Olympics Bharat – Tripura Chapter from 10 to 11 December, 2012 at Kailasahar, Unakoti District with the cooperation of District Administration, Unakoti and 19 to 20 December, 2012 at Belonia, South Tripura District with 50 participants (both male and female) in each Training. TRAINING PROGRAMMES ON GERIATRIC CARE /CARE FOR ELDERLY UNDER NATIONAL INSTITUTE OF SOCIAL DEFENCE (NISD)

The increase in the population of the older persons is a global phenomenon, and India is no exception. So, there is an urgent need of ensuring care to this segment of the population that would soon exceed the population of available Care Givers. Realizing the magnitude of the challenge, the Government of India, Ministry of Social Justice and Empowerment announced in January, 1999, a National Policy on Older Persons (NPOP). In question of implementation of the NPOP, the NISD has launched a Project "National Initiative on Care for Elderly (NICE) to address the needs of the older persons. The Main objective is to develop a cadre of frontline skilled/trained personnel of Geriatric Care Givers that specializes in home care family and community settings. The younger generation and others concerned with the welfare of older persons are to be encouraged to attend the needs of the older persons. Accordingly NISD has selected Abhoy Mission only in Tripura to shoulder the liability in the year 2005 to conduct the training courses. Since then Abhoy Mission has been conducting the courses. A good number of cadres have already been created by this time and they have been going on providing their services. The below noted courses and programmes are undertaken and completed during the year -

- Six Months' Certificate Course in Geriatric Care for 30 trainees.
- One Month's Certificate Course in Geriatric Care with a capacity of 30 seats.
- 20 Days' Community Training in Computers for Senior Citizens with a capacity of 20 seats.
- Five Days' Training Programme on Capacity Building of Key Functionaries of NGOs in Geriatric Counselling.
- One Day's Sensitization Programme for Senior Citizens Forum / RWAs.
- One Day Sensitization Programme for School / College Teachers / Students / Youth to Bridge Intergenerational Gap with Focus on Maintenance & Welfare of Parents & Senior Citizens.

Training of In-service Teachers in Special Education is an essential effort in the field of education for Special Need Children. In as usual system of education, the teachers are teaching the normal students. Since inception of Sarva Shiksha Abhiyan in the Country, it is felt necessary to get the teachers trained in Special Education looking at the betterment of the CWSN and after the Right to Education Act. has come into force, the necessity and significance of special education has increased to a greater extent. Keeping this in view, the Rehabilitation Council of India, Govt. of India has accorded recognition to Abhoy Mission only in Tripura State to conduct the following training programmes under different Universities for manpower development.

As a result, few teachers have got trained in the above mentioned field and have created an environment of meaningful education in the field of Special Education. In Inclusive Education system, the CWSN are getting adequate opportunity to go to the normal school for gaining studies and have become able to exchange their views to each other. We are conducting Foundation Course on Care Giving under RCI from 2007 and subsequently Sahyogi – Care Giver Training Course since 2009 under National Trust, Govt. of India, mainly aiming to provide, promote, create and maintain a good number of care givers for persons with disabilities (PwD), duly educating the needy people of illiterate sector to join happily with the mainstream of the country with employment and self dependence etc.

FAMILY SERVICE.

Early intervention

Early intervention is the basic issue for the children with disabilities. Most of the parents do not understand what is going on to their babies. They become thoughtful about them. At this stage, we advice the parents to bring their babies to the Physician, Psychiatrist or Physiotherapist, according to the need of the babies, for their better development. At the same time the parents are also advised to handle their babies according to their needs. In some cases, we provide Trained Care Givers who go to their family and nurture their babies.

School Readiness Programme.

The parents of the children are advised to send them to either in Anganwadi Centre, Special School or in nursery well in advance, so that they can learn to get ready for school as a regular course of habit. We also deploy Care Givers to the family for preparing the babies to go to school.

Counselling.

Most rural parents have no knowledge about disabilities. We conduct advocacy & counselling programme for the parents in the habitations. Skilled persons in the field of disabilities approach the parents both individually and collectively to make them informed on different issues. Emphasize is given on the issue of collecting Disability Certificate from DDRC, Niramoy Health Insurance & Legal Guardianship etc.

LIBRARY OF ABHOY MISSION, RAMNAGAR, AGARTALA, TRIPURA.

To facilitate study for the students of the Study Centre, we have a library in operation in our Organisation. There are 1261 nos. of books and 200 nos. magazines in the library. The broad classification of books is as such-
