#### **Activities for Senior Citizens**

In the year 2018-19 performance of Abhoy Mission for senior citizens were performed in different ways -

- A. Rehabilitation Centre for Senior Citizens (Old Age Home) Abhoy Ashram.
- B. Community Based Rehabilitation for Senior Citizens.
- C. Rehabilitation of Senior citizens through helpline and Counseling Centre.

#### Rehabilitation Centre for Senior Citizen (Old Age Home)- 'Abhoy Ashram'

A Rehabilitation Centre for Senior Citizen, namely "Abhoy Ashram", was set up in the year 1993 to make round the clock care by the trained & skillful service providers accessible for them. Beneficiaries are being admitted in the centre with recommendation of Social Welfare & Social Education Department, District Legal Services Authority, Gram Panchayat, and Women Commission & Police.

Restoration of happiness and well-feeling in senior citizens, who have basically no shelter & caretaker in their family, from physical, mental and social point of view is the focus area of the program.

Facilities like healthcare, nutrition, physiotherapy, occupational therapy, arrangement for recreation, ambulance, hot water plant are being provided to the elderly beneficiaries to keep them fit physically and mentally.

To stay the elderly persons well from psyche point of view, the beneficiaries are helped to take opportunities to involve themselves in community and social programs. They get occupied themselves in observation of Independence Day & Republic Day. They visited pandals during Durga Puja Festival. They observed New Years Day, Rathayatra, Manasamangal & Manasa Puja, International Day for Older Persons, Kojagari Purnima, Deepavali, Christmas Day, Makar Sngkranti, Shiva Chaturdashi and Doljatra in Abhoy Ashram.

Tracing and counseling the family members, so that the old age persons can be restored in family environment, is an ongoing process from our side.

Smt. Saraswati Debnath, on 28-05-2018, alone came to our office and expressed desire for admission in Old Age Home. She used to work in G.B. Pant Hospital in Agartala. After admission, she started staying in our Old Age Home. By this making contact with her son realized and counseling was done to her son. Few days later, her son and daughter-in-law came to our office and had taken back her in house. From experience of conducive environment in our Old Age Home Smt. Saraswati Debnath still visits our Old Age home from time to time.

Few lines regarding restoration beneficiaries of Old Age Home, Laxmi Das, Kiranbala Debnath, Nirmala Debnath and Basana Das have been scribed below-

Kiranbala Debnath was admitted in Old Age Home with District Legal Service Authority (DLSA) recommendation. Due to similar effort, sister of Smt. Kiranbala Debnath, accepted her sister in her own family in Jolaibari of South Tripura District on 04-08-18 with due permission of DLSA.

By counseling, niece of Laxmi Das, of Rangutia under Bamutia R.D. Block, become active and with her initiative, Smt. Das returned to family environment on 28-08-18. Nirmala Debnath was admitted with recommendation of District Legal Service Authority, West Tripura District. On 03-11-18, Sri Banka Debnath of A.D. Nagar, Agartala, had taken

back his mother, Smt. Nirmala Debnath to his family. On 26-12-18, youngest son, daughter-in-law and granddaughter of Smt. Basana Das, came to take back her in their House in Jagatpur near Abhoynagar, Agartala.

Service provided till this year from inception = Nos. 210 aged persons

#### **Case History of Chhaya Bhattacharjee**

Chhaya Bhattacharjee took birth in Digboy, Assam in the year 1957. He mother late kiran Bhattacharjee died within short time after her birth. Her father, late Mukunda Chandra Bhattachrjee was a physician, working in a Tea Estate. After her birth, late Mukunda Bhattacharjee shifted to Khowai of Tripura. Her father died at her 08/10 months age. She was nurtured by her maternal grandmother in Khowai. Her cousin late Brajadulal Bhattacharjee took her to his House at Agartala. But her sister-in -law did not like her. She left schooling, when she was in class IX. She married late Balai Debbarma, a contractor of Bijoy Kumar Chowmuhani when she was 17 years old only. Late Balai Debbarma was alcoholic. He compelled to sell his property including the dwelling place to meet up his regular demand for alcohol. Her daughter studied up to Class IV and got married in early age. Chhaya Bhattacharjee started residing in rented house. She used to earn her livelihood by working as domestic assistant. health, she was not in a position to work as domestic assistant. Ujiwayant Market near Orient Chowmuhani ultimately became her resort for night stay. She used to take 'madhukari' in Jagannath temple in day time. She used to respond to natural call and took bath in Sulabh toilet under the disposal of Agartala Municipal Corporation. On the evening of Kali puja, 6<sup>th</sup> November, 2019, Secretary, Abhoy Mission noticed her. Her body was bent forward and swollen due to mosquito bites. On enquiry it was revealed that she could sing and recite poems. Smt. De told her to enroll in Old Age Home managed by Abhoy Mission in the next day. After her enrolment, Chhaya Bhattacharjee had to undergo medical checkups and several biochemical tests. She was allowed to take rest and engage self in recreational activities. Now Chhaya Bhattacharjee is a completely different lady.

#### **Community Based Rehabilitation to Senior Citizens**

#### CBR with support from Help Age India

With support from Help Age India, Abhoy Mission has been continuing Community Based Rehabilitation Program for elderly people through 'Adopt A Gran' (AAG) project since 2003. The project was renamed as 'Sponsor a Grand Parent' (SaGP) project in the year 2010. Currently the project is being run with the name 'Astitva.

Facilitating the countryside senior citizens to survive with esteem within their families is the most important purpose of the program. Based on consultation and

requirement of beneficiaries, food grains, clothes, garments, mosquito nets, pocket money etc. are provided to 50 aged parents

#### CBR with support from Give India

Give India, a donation podium for providing gracious support all through the country, is providing fundamental support to elderly citizens in Tripura. We communicate our best appreciation to Give India.

Restoration of emotional and societal well being in old people in rural areas through support in the sector of nutrition, health, hygiene and encouraging freedom are the primary purposes of the program.




Fig.1 CBR to Elderly with support from Give India in 2018-19  $\,$

CBR support is being provided through two package i.e. @Rs.530/- and @Rs.525/-Ration & toiletries per month are given to elderly people as a means of raising standard of living and removal of feeling of considering self as burden in the family. Grant for medical expenses is included in those packages. Support provided to number of elderly people in different months of 2018-19 has been shown in Fig 1

#### CBR with initiative of Abhoy Mission

Abhoy Mission this year decided to support senior citizens belonging to below poverty line category of rural areas of West Tripura and Sepahijala District so that they can maintain themselves healthy despite the assault of virulent cold in the winter. For that reason, the organization took initiative to distribute blanket among elderly of such category. In total, 200 blankets were distributed in Gakulnagar G.P. under Sepahijala

District and Ishan Chandra Nagar of West Tripura District on 19/01/2019 and 29/01 / 2019 respectively.

#### CBR through Helpline and Counseling Centre

Helpline service working during day and night is being provided to senior citizens who are under pressure being alone and with insecurity, anxiety, domestic aggression etc. Medical help, police help, service of caregiver, physiotherapy, counseling & advocacy within the family and community are being provided from here.

In the last day of January, 2019, on call of Public of Abhoynagar area, West Agartala Women Police Station apprehended an old lady, with name **Shauntala Das**. She was willing to go to any Old Age home. She was given refuge to Abhoy Ashram. From Adhaar Card and other documents taken along with her, location of her home was traced out. Regular Counseling was given to her. On 26-02-2019, she was taken to her house in Ananga nagar, Narayanpur. Counseling was made to family members. Shauntala Das was accepted by her family.

Kunja Namah of Binpara, Lankamura under West Tripura District left her family with grievance on 21<sup>st</sup> March, 2019. She was taken to our Counseling Centre. After hearing total case, counseling was made to her to register the case in the West Agartala Women Police Station. Temporarily, Smt. Namah was given refuge in Abhoy Ashram. Next day, Secretary of Abhoy Mission herself with Police Personnel of the Women P.S., visited the House of Smt. Namah and made counseling to family members. On 28-03-2019, son, daughter-in-law and granddaughter of Kunja Namah came to Abhoy Mission. View of union of family members was unforgettable. The granddaughter embraced Smt. Namah with her small arms with unfathomable emotion and laid her head upon grandmother's shoulder. Smt. Namah returned to her home same day.

In the year 2018-19, the dealings for development of children and young with disabilities were as follows-

- A. Swabalamban Special School for Children with Multiple and Intellectual Disabilities
- B. Swabalamban Rehabilitation Centre for Orphan Children with Special Needs
- C. Vocational Training for Individuals with special needs
- D. Community Based Rehabilitation for Children with Special Needs
- E. Training program for different sections of community in association with the National Institute for Mentally Handicapped.
- F. State Nodal Agency Centre (SNAC), Tripura State under National Trust

## Swabalamban Special School for Children with Multiple and Intellectual Disabilities

The first special school, for children with intellectual disabilities, in the State of Tripura, the 'Swabalamban' begins its journey on 26<sup>th</sup> January, 1991, with only 05 students. Sixty students are taking education in this school. The school is located in Gakulnagar Gram Panchayat under Sepahijala District.

The endeavor of the program is education to children with multiple and intellectual disabilities through dealing with their individual exceptionality.

Education involves individual education program and monitoring system by means of adapted apparatus and resources.

Training to develop personal skills including daily living skills, social, academic & occupational skills are provided to children with special needs. Besides, training in Arts, Music, Dance and prevocational training is being provided to them. Children are being encouraged to acquire skills in sports & games.

#### Community Based Rehabilitation for children with disabilities through support from Give India

Proficiency training in dwelling places and nutritional support are being provided to children with multiple disabilities. Children were supported through per month donation option of Rs.860/- & Rs.125/-.






Fig 2. CBR support to children with disabilities from Give India in 2018-19

#### Swabalamban Rehabilitation Centre for Children with Special needs

Complying with rules of Integrated Child Protection Scheme (ICPS) under Ministry of Women and Child Development, Govt. of India, Abhoy Mission is operating a Child Care Institution (CCI) under the nomenclature of 'Swabalamban Rehabilitation Centre for children with special needs'. The CCI is registered with the Government of Tripura, Directorate of Social welfare & Social Education vide Registration No.03 under Juvenile Justice Act, 2015.

<u>Objective</u>- To provide care & protection to children with special needs, especially orphan, in secured environment is the objective of the program.

Girls within the age range of 6-18 years and boys above 06 years & below 10 years are admitted in the CCI. Total seat capacity is 50. By the end of 2018-19 there were 46 enrolled children in the Rehabilitation Centre. Out of them, 28 are enrolled in normal inclusive school.

Health Care facilities including physiotherapy service, Nutrition, emotional support, training for developing personal skills, social, academic & occupational skills, prevocational & vocational training are being provided to special need children on the basis of current individual abilities. Besides ample opportunities for recreation is provided to facilitate all round development including cultural and environment consciousness in them.

To encourage all round development in beneficiary children, they are supported to take part in different community program and liaison with different institutions and group is maintained in this regard. On the occasion of Tripura State Rifles Foundation Day, on 18-06-2018, the special need children of Swabalamban Rehabilitation Centre performed dance in TSR 1<sup>st</sup> Battalion Head quarter at Birbandhugram, Gakulnagar. Smt. Supriya De, Superintendent of the Centre participated in the Briksharopan program in that occasion. On 2<sup>nd</sup> September, 2018, Lions Club of Agartala and ONGC Employees Union of Tripura jointly organized a Health Camp in Swabalamban Rehabilitation Centre. President of Lions Club, Dr. P.K. Bhattachrjee and General Secretary of the Emplyees Union, Sri Birchandra Debbarma were present in the program.

Quarter –wise enrolled children in the Rehabilitation Centre was as shown in the following graphical presentation




Fig 3. Number of enrolled children with special needs in Rehabilitation Centre in 2018-19.

#### **Case History of Kiranjyoti**

Kiranjyoti Parbati alias Chiranjit Sinha was traced in Peratia Bazar on 12-09-2017 ad as per placement order of CWC, undivided South , Udaipur vide Case Profile No. 30/CNCP/South & Gomati dated 15-09-17, the child was enrolled in Swabalmban Rehabilitation Centre for Children with Special Needs, Gakulnagar under Sepahijala District on the same date. He stayed in this Children Home for almost one year and exhibited improvement from social, academic and personal skill point of view. With hard effort of from DCPU, Sepahijala District of Tripura and DCPU, Dibrugarh of Assam State, family & house of Kiranjyoti was traced in Kuiharbari, Dikom sessa in Dibrugarh SubDivision of Assam. On 4<sup>th</sup> September, 2018, CWC, Sepahijala District issued Order in favour of restoration of Kiranjyoti to his famiy vide case no.44/D/2018 dated 04-09-2018.

For the purpose of restoration of Kiranjyoti Parbati alias Chiranjit Sinha a team comprising Sudip Datta, Child Welfare Officer, Sri Rajib Kr. Roy, House father of Swabalamban Rehabilitation Centre for Children with Special Needs, Gakulnagar, Sri Gautam Sarkar, member, Child line and Sri Bimal Baidya, Sub Inspector of Bishramganj P.S. started for Dibrugarh escorting Kiranjyoti via Kolkata through Indigo Flight 6E-833 on 16<sup>th</sup> September, 2018.

Kiranjyoti with all necessary documents and his belongings were produced before CWC, Dibrugarh District, Assam. Child Welfare Committee took undertaking from Stepfather of Kiranjyoti, Sri Pradip Singha that he will carry out all the responsibilities

regarding protection, nutrition, education, health &hygiene of Kiranjyoti and temporarily handed over Kinranjyoti to his mother, Smt. Manjitha Parbati & step father.

All four members of Tripura team along with Arpana Borah & Farhin Rahman, both member of CWC and Anwar Ansari, Social Worker visited the house of Kiranjyoti in Kuiharbari of Dikam Sessa, P.O. Bosapthar, P.S.Lahowal under Dibrugarh Sub Division on 18<sup>th</sup> September, 2018. On conversation it was revealed that earlier KIranjyoti along with his mother, father late Shivakanta Handique and younger sister Sumita was residing in in Naharsuk, not far away from his present address. Shivkanta was suffering from liver disease and committed suicide. Four years back Manjita married Pradip Singha. Then the team visited Dakshin Dikom Sessa Lower Primary School where Kiranjyoti was studying two years back. Girish Gogoi, Head Master of that school was requested to enrol Kiranjyoti again in the school if he is finally restored to his family. Sri Gogoi made commitment to extend cooperation in this regard.

#### **Rehabilitation Centre for treated and controlled Mentally ill females**

Long stay in Psychiatric Hospital for treated and controlled mentally ill patients usually brings negative impact on their skill of Activities of Daily living and of socialization. In the month of September, 2018, Abhoy Mission started a Rehabilitation Centre for such treated and controlled mentally ill females so that they can regain skills for independent living in society. On 27<sup>th</sup> September, in a program held in Modern Psychiatric Hospital, Narsingarh, Hon'ble Health Minister of Tripura, Sri Sudip Roy Barman handed over 10 treated and controlled long stay mentally ill females of Modern Psychiatric Hospital to the President of Abhoy Mission, Sri Shyamal Deb. Vocational Training, nutrition, medicines, pranayam & yoga as per advice of psychiatric doctors, treatment of other incidental illness and recreational provisions are being provided in the Rehabilitation Centre.

#### Dol Purnima and Holy, 2019



An Awareness Program lead by SNAC, Coordinator was organized on difficulties & inclusion of special need children within the scope of National Trust Act, 1999. The students interacted with beneficiaries, especially special need children. They sang music and shared dances with children beneficiaries.









#### **Meeting of Local Level Committee of West Tripura District under National Trust**

A meeting of Local Level Committee of West Tripura District under National Trust was held in the office chamber of District Magistrate and Collector on 5<sup>th</sup> July, 2018. Besides DM & Collector, Dr. Sandeep Mahatme Namdeo, Miss Susmita De, Coordinator SNAC, Tripura, Statutory PwD Member, Sri Subrata Ganguly, Chief Medical Officer, West Tripura District, The Superintendent of Police (Admn), Tripura and Sri Satyabrata Pal, Advocate were present in the meeting. The meeting decided that all Guardians should submit property return (movable and immovableaaaaaaaaaa0 at the time applying for Legal Guardianship. It was also decided that every Legal Guardian should submit property return once in a year. Coordinator, SNAC was authorized to conduct home visit before sending the proposal for issuing Legal Guardianship Certificate to the Chairperson of Local Level Committee.

#### Counseling

We make counseling to parents regularly so that they can extend support to their children, on the basis of each child's individual need and current level of performance. Even after counseling, we extend our institution based physiotherapy support to children if found necessary. In addition, we organize sensitization programmes for parents of children with special needs.

#### **School Readiness Programme**

Hard work is being done to inspire the parents & family members to take their children with special need to Anganwadi centre or Nursery schools or in Special schools to make smooth the progress of readiness programme. We arrange Care Givers to develop children with special needs for regular schooling.

#### Infra- structural Development in Abhoy Ashram Area in the year 2018-19

As per sanction of President of India, Ministry of Women & Child Development, Govt. of India, handed over the Central share amounting Rs. 89.41 lakh to Govt. of Tripura, for construction of Children home for Special Need Children in Abhoy Ashram in 2016. In the same year, the Member Secretary, State Child Protection Society, Government of Tripura handed over the amount to the District Magistrate & Collector of Sepahijala District and asked him to complete the said construction. NGO share of Rs.9.94 lakh for the same work was handed over by Abhoy Mission to the DM & Collector of Sepahijala. The construction work was completed in the year 2018-19 and the single storey building was handed over to Abhoy Mission.

To provide physiotherapy service more efficient way, **Give India** provided support to us to put updated physiotherapy equipment in Abhoy Ashram.

To provide updated physiotherapy service for children with multiple disabilities and locomotor disabilities, the **National Institute for Empowerment of Persons with Multiple Disabilities (NIEPMD)**, under Govt. of India, provided support for installing up to date physiotherapy equipments.

To maintain 24 hours power supply in the Abhoy Ashram area, ONGC, Tripura Asset, provided support to Abhoy Mission to install solar power plant in Abhoy Ashram. NB Institute of Rural Technology extended their technical support in this regard.

#### Future plan

- Supporting persons with visual impairment and intellectual disabilities with mobility aids and teaching learning aids.
- Mobile Medical Service to provide preliminary health care support to the population who are not in a position to take advantage of Primary Health Centres.
- Deafblind project for the support of persons with deafblindness.
