From the Writing Table (2020-21)....



With supreme admiration to our COVID warriors — who are fighting tooth to nails to save lives and safeguarding the affected people wishers in our society, I commence communication from this writing table. Even in normal circumstances, persons with disabilities are less likely access health care, education, employment and to participate in the community. COVID 19 is deepening pre-existing inequalities and exposing the extent of exclusion. The elderly population in India has been the most

vulnerable group in COVID 19 pandemic contributing to 53% of the reported fatalities because age increases the risk of severe illness. As 56% of the population lives in below poverty line standard, financial stringency provides little opportunity to the young income holders of a family to provide care & dignity to older persons and old persons find little access to nutrition, healthcare and participation in the community.

We are functioning steadily for an inclusive, accessible and sustainable world in COVID 19 situations and maintaining the same in post-COVID too. We have been trying to reach these disadvantaged with nutrition, healthcare materials since last week of March, 2020. Convergence of different agencies was also part of our Mission in this regard.

Outlook of the human world, as a whole, towards elderly & persons with disabilities and way of resolving their issues changed to a considerable degree towards inclusion in terms of protection of rights, equal opportunities and full participation. COVID 19, certainly, erected number of barriers on the course of realization of inclusion of those disadvantaged people.

I convey my gratitude to different Ministries of Govt. of India, National Institutes of Disabilities, Govt. of Tripura, Panchayet Raj Institutions, our collaborator institutes & staff volunteers & well fisheries of our organization for extending honest & heartfelt efforts in our mission.

Even modest offerings from common people may make possible a gigantic progressive movement for disadvantaged section of mankind including Divyangjan and old persons at the present crisis period. We are appealing to all to join the process of supporting the disadvantaged to sustain and to provide shape for a real inclusive human society.

Activities for Senior Citizens

In the year 2020-21 efforts of Abhoy Mission for senior citizens were executed in diverse ways -

- A. Rehabilitation Centre for Senior Citizens (Old Age Home) Abhoy Ashram.
- B. Community Based Rehabilitation for Senior Citizens.
- C. Rehabilitation of Senior citizens through helpline and Counseling Centre.

Rehabilitation Centre for Senior Citizen (Old Age Home)- 'Abhoy Ashram'

"Abhoy Ashram", a Rehabilitation Centre for poor & protection less elderly, commenced its work in the year 1993 to provide round the clock care by the trained & dexterous service givers. Beneficiaries are being enrolled in the centre with reference of Social Welfare & Social Education Department, District Legal Services Authority, Gram Panchayats, and Tripura Commission for Women & Tripura Police.

Reinstatement of happiness and healthy sensation in elderly, who have no refuge & custodian in their family, from physical, psychological and social point of view, is the focal point of the program.

Service in different areas like healthcare, nutrition, physiotherapy, occupational therapy, recreation is being provided to enrolled senior citizens. Arrangement of ambulance, hot water plant and solar power plant is there in the Home to provide 24 hours smooth and effective service in a day.

To stay the elderly persons well from psyche point of view, the beneficiaries are helped to take opportunities to involve themselves in community and social programs. They get occupied themselves in observation of Chaitra Sankranti, New Years Day, Akshay Tritiya,Buddha purnima,Rabindra Jayanti, Rathayatra, Manasamangal,Manasa Puja, Independence Day, Laxmi Puja, Diwali, Kali puja, Bhatridwitiya, Makar Sangranti, Republic Day Saraswati Puja,Shiva Chaturdashi, Dolyatra and Holi Festival. They visited pandals during Durga Puja Festival.

Community Based Rehabilitation to Senior Citizens

CBR with support from Help Age India

With support from Help Age India, Abhoy Mission has been working in Community Based Rehabilitation Program (CBR) for poor old people through 'Adopt A Gran' (AAG) project since 2003. At present, the project is being run with the name 'Astitva'.

Making feasible for countryside senior citizens to stay alive with esteem within their families is the most noteworthy objective of the program. On the basis of discussion and necessity of beneficiaries, food grains, clothes, garments, mosquito nets, pocket money etc. are provided to 24 aged parents

CBR with support from Give India

Give India, a donation platform for providing genial support all through the country, is providing elemental support to elderly citizens in Tripura. We convey our best admiration to Give India.

Restoration of emotional and societal well being in old people in rural areas through support in the sector of nutrition, physical condition, hygiene and promoting freedom are the most important purposes of the program.




Fig1. CBR Support to elderly by Give India through two packages in 2020-21

CBR support is being provided through two package i.e, @Rs.530/- and @Rs.525/Ration & toiletries per month are given to elderly people as a means of raising standard of living and removal of feeling of considering self as burden in the family. Grant for medical expenses is included in those packages. Month-wise support provided to number of elderly people in different months of 2020-21 has been shown in Fig 1

CBR through Helpline and Counseling Centre

Helpline service working during day and night is being provided to senior citizens who are under pressure being alone and with insecurity, anxiety, domestic aggression etc. Medical help, police help, service of caregiver, physiotherapy, counseling & advocacy within the family and community are being provided from here.

In the year 2020-21, the dealings for development of children and young with disabilities were as follows-

- A. Swabalamban Special School for Children with Multiple and Intellectual Disabilities
- B. Swabalamban Rehabilitation Centre for Orphan Children with Special Needs
- C. Vocational Training for Individuals with special needs
- D. Community Based Rehabilitation for Children with Special Needs

- E. Training program for different sections of community in association with the National Institute for Mentally Handicapped.
- F. State Nodal Agency Centre (SNAC), Tripura State under National Trust

<u>Swabalamban Special School for Children with Multiple and Intellectual</u> <u>Disabilities</u>

The first special school, for children with intellectual disabilities, in Tripura, the 'Swabalamban' begun its journey on 26th January, 1991. 45-46 students are passing through teaching learning course in this school in this year. The school is positioned in Gakulnagar Gram Panchayat under Bishalgarh R.D. Block.


The purpose of the mission is to offer education to children with multiple and intellectual disabilities through dealing with their individual strength & needs.

The effort is busy with individual education program and monitoring system with the help of adapted equipments and resources.

Training to develop personal skills including daily living skills, social, academic & occupational skills are provided to children with special needs. Besides, training in Arts, Music, Dance and prevocational training is being provided to them. Children are being encouraged to acquire skills in sports & games.

Community Based Rehabilitation for children with disabilities through support from Give India

In the year 2020-21, capacity building in residence and dietary support are being provided to children with multiple disabilities. Children were supported through per month donation option of Rs.860/- & Rs.500/-.

Swabalamban Rehabilitation Centre for Children with Special needs

Complying with the provisions & policy of Child Protection Service (CPS) scheme under Ministry of Women and Child Development, Govt. of India, Juvenile Justice (Care and Protection of Children) Act, 2015, ABHOY MISSION is running a Child Care Institution (CCI) under the nomenclature of 'Swabalamban Rehabilitation Centre for children with special needs' in Gakulnagar GP of Bishalgarh Sub-divisional area. Accessibility to care & protection for children with special needs, especially orphan, in protected setting is the rationale of the program.

The CCI is documented with the Government of Tripura, Directorate of Social welfare & Social Education with Registration No.03 under Juvenile Justice Act, 2015.

Girls, within the age range of 6-18 years and boys above 06 years & below 10 years are enrolled in the CCI with appropriate order & recommendation of Child Welfare Committee of any District of Tripura State. Total seat capacity is 50. On the concluding day of financial year 2020-21, there were 45 enrolled children in the Rehabilitation Centre. Nearly three- fifth of them have been enrolled in normal inclusive school.


The centre, on the basis of existing level of individual abilities of special need children, provides following service facilities-

- i) health Care facilities together with physiotherapy service, nutrition, emotional care,
- ii) education for developing personal skills, social, academic & occupational skills,
- iii) pre-vocational & vocational training,
- iv) amusement activities.

All facilities act in concert with the service from competent personnel for smooth progress in all round development in the children.

Children are supported to participate in diverse programs. Within Swabalamban Rehabilitation Centre the children observed Independence Day, Republic Day, National Teachers Day, International Yoga Day, Laxmi Puja, Bhatridwitia, Manasa Puja and other Social Festival.

Rehabilitation Centre for treated and controlled Mentally ill females

Long stay in Psychiatric Hospital for treated and controlled mentally ill patients usually brings negative impact on their skill of Activities of Daily living and of socialization. In the month of September, 2018, Abhoy Mission started a Rehabilitation Centre for such treated and controlled mentally ill females so that they can regain skills for independent living in society. On 27th September, in a program held in Modern Psychiatric Hospital, Narsingarh, Hon'ble Health Minister of Tripura, Sri Sudip Roy Barman handed over 10 treated and controlled long stay mentally ill females of Modern Psychiatric Hospital to the President of Abhoy Mission, Sri Shyamal Deb. Vocational Training, nutrition, medicines, pranayam & yoga as per advice of psychiatric doctors, treatment of other incidental illness and recreational provisions are being provided in the Rehabilitation Centre.

Battle against COVID 19

The year 2020, was severely hit by a lethal virus called COVID 19. To protect elderly in the Old Age Home and special need children in Child Care Institution, located in Abhoy Ashram area, from this deadly virus, several measures were taken. The following measures can be considered noteworthy –

- i) giving training to elderly and children to maintain COVID 19 rules,
- ii) regular health check up,
- iii) Keeping adequate amount of sanitizer and hand wash in the premises,
- iv) washing of clothes daily by detergent powder and Dettol antiseptic liquid,
- v) cleaning of every utensils by use of hot water and washing soap,


- vi) Cleaning and washing of Kitchen areas along with sanitization for thrice a day by the workers with phenyl and Dettol antiseptic liquid,
- vii) Cleaning the bathrooms and toilets for two times a day with Harpic toilet cleaner, bleaching powder and detergent powder,
- viii) provision of separate sick room with an adequate capacity keep the old people in isolation.

On 2nd April, 2020 an inspection team came from Sub-Divisional Magistrate Office, Food Department and District Inspector, Social Welfare and Social Education, Sepahijala District, Govt. of Tripura for checking the arrangement taken by Abhoy Ashram as precautions from Covid-19. A similar inspection for checking arrangement and the health status of inmates was held by **Central Task Force**, Govt. of India on 30th April, 2020.

In response of The Hon'ble Prime Minister of India, Shri Narendra Modi's call of 'Diya Jalao India' every senior citizen o and specialneed children of Abhoy Ashram lit candles for 9 minutes to fight against corona virus on 5th April, 2020.

On 28th August, on instruction of District Magistrate and Collector, Sepahijala District the children, old beneficiaries and office staffs of Abhoy Ashram went under Reverse transcription polymerase chain reaction test (RT-PCR) for Corona virus. On 3rd October again, the children, old beneficiaries and office staffs of Abhoy Ashram went under RT-PCR test for Corona virus.



On 3rd October, again by the instruction of District Magistrate and Collector, Sepahijala District the old beneficiaries, children and office staffs of Abhoy Ashram went under Reverse transcription polymerase chain reaction test (RT-PCR) for Corona virus.



The generous work of helping the affected section of society was started by donating Rs.1, 11,111/- Rupees (One Lakh Eleven Thousand One hundred and eleven) only to Chief Minister's Relief Fund, Tripura by handing over the cheque (No. 369188- Axis Bank, Dated30/03/2020) to Smt. Pratima Bhowmik, Hon'ble MP from Tripura on 30/03/2020 by the President of Abhoy Mission Sri Shyamal Deb. This was the first step in our collective battle against Covid19.

CBR with support from GIVE INDIA in respect of COVID 19

With guidance and support from Give India, ABHOY MISSION took several activities to assist the elderly and divyanjan of Tripura State who fell in misery due to COVID 19 affected situation. Founder President of the organization late Shyamal Deb took special initiative to implement the programs.

On 29-05-2020, a program, graced by the presence of Smt Antara Deb Sarkar, Zilla Sabaditipati, Paschim Tripura Zilla Parishad, was arranged by Abhoy Mission Conference hall at Abhoy Ashram, for distribution of assistance to 21 needy senior citizen and their families from various Gram Panchayet of Sepahijala District. A **Cheque amounting Rs 5,000/- was given to each** of the poor senior citizens at this pandemic period as medical support.

Awareness Cum Nutritional Kits Distribution under Bishalgarh RD Block

On 28th June, 2020, sensitization camp and nutrition support was provided in Purba Laxmibil and Madhya Laxmibil Gram Panchyat. In total, 101 families were benefitted through this program.

On 29-06-2020, awareness cum distribution programs was organized in Prabhurampur GP and Gakulnagar GP under Bishalgarh RD Block of Sepahijala District. Support was provided to 110 no. of families in total.

On 2nd October, 2020, support program and sensitization was arranged in Bhatibari and Lembutali GP. 15 families were supported by this program.

On 27th March, 2021, awareness cum distribution program was organized in Gakulnagar Gram Panchayet. Support was given to 167 nos. beneficiaries through nutritional kits, each composed of Rice 20 kg, Pulses 2kg, wheat flour 1 kg, Soybean 500 gram, 2 soaps, Mustard oil 500 ml, Sugar 1 kg, Onion and Potato 5 kg, Tea leaves 100 gram Mask 3 pieces, Hand Sanitizer, Tooth brush and tooth paste.

In collaboration of Sepahijala Zilla Parishad ABHOY MISSION arranged awareness cum distribution program on 31st March, 2021for the people who stays in a very distress condition at Harishnagar Village. The beneficiaries of this area chiefly composed by Indigenous Tribe people of Tripura and Austro Asiatic group of people. In total 66 beneficiaries attended the program. Smt Supriya Das Dutta, Hon'ble Sabhadipati of Sepahijala Zilla Parishad graced the program. Volunteers from the local communities also extended their sincere support to make the program successful.

Awareness Cum Nutritional Kits Distribution under Charilam RD Block

On 08-07-2020, awareness cum distribution programs was organized in Lalsingmura ADC village under Charilam RD Block of Sepahijala District. Nutrition support was provided to 24 nos. of families having.

Awareness Cum Nutritional Kits Distribution under Jampuijala RD Block

On 08-07-2020, sensitization as well as nutritional distribution programs was organized in Latiacherra ADC village under Jampuijala RD Block of Sepahijala District. 08 families were benefitted through this program.

Awareness Cum Nutritional Kits Distribution under Nalchhar RD Block

On 28-08-2020, sensitization cum nutrition support program was organized in Poangbari GP and Chandanmura GP under Nalchhar RD Block. In total 50 families were benefitted through this program.

Awareness Cum Nutritional Kits Distribution under Boxanagar RD Block

On 29-08-2020, awareness as well as distribution of nutrition program was conducted in Veluarchar and Kalshimura GP under Boxanagar RD Block. In total 40 families were benefitted from the program.

Awareness Cum Nutritional Kits Distribution under Mohanbhog RD Block

On 26th September, 2020, in Garurbandh, Kalamket and Kathaliamura Gram Panchayats under Mohanbhog RD Block, sensitization cum nutrition support program was arranged. In total, 50 families were supported through this program.

Awareness Cum Nutritional Kits Distribution under Dukli RD Block

On 2nd October, 2020, awareness program and support of nutrition and sanitization material was organized in Dakshin Champamura GP of Dukli RD Block. 10 families were benefitted through this program.

On 10th March, 2021, Abhoy Mission, in association with Paschim Tripura Zilla Parishad, arranged awareness programs and extended support in the form of nutritional and sanitization materials within the grand old people and special need persons and their families who were affected by shrinkage of opportunity for employment as a result of Corona pandemic situation in Anandanagar, Malaynagar Rangamatipara, Srinagar GPs and Kalidas Para, Jarul Bachai ADC village areas. In total 85 elderly and divyangjan were benefitted through this program.

In collaboration of Paschim Tripura Zilla Parishad Abhoy Mission arranged awareness cum distribution program on 31st March, 2021 in Sekerkote, Bikramnagar, Ishanchandranagar, Khas Madhupur, Ballavpur GPs under Dukli RD Block area. Hon'ble Sabhadhipati of Paschim Tripura Zila Parishad, Smt. Antara Deb Sarkar graced the programs. Totally 184 aged and special need persons were benefitted through this program.

Awareness Cum Nutritional Kits Distribution under Mohanpur RD Block

On 19th October, 2020, awareness program and support of nutrition and sanitization materials was arranged in Gopalnagar Tea Estate under Mohanpur RD Block of West Tripura District. 52 families were supported through this program.

<u>Awareness Cum Nutritional Kits Distribution under Agartala Municipal</u> Corporation area

On 21st October, 2020 Abhoy Mission arranged arranged awareness program and support in the form of nutrition and sanitization materials in Bin Para slum areas under

Agartala Municipal Corporation area. In total, 73 families received benefit through this program.

Awareness Cum Nutritional Kits Distribution under Bamutia RD Block

On 5th March, 2021, Awareness cum Nutritional Kits Distribution program was conducted amongst elderly and divyangjan people in Patunagar, Durjoynagar, Nutannagar, Dighalia, Ananganagar, Singerbill, Berimura, Paschim Bamutia and Purba Bamutia GPs under Bamutia RD Block. To support these beneficiaries nutritional kits, each composed of Rice 20 kg, Pulses 2kg, wheat flour 1 kg, Soybean 500 gram, 2 soaps, Mustard oil 500 ml, Sugar 1 kg, Onion and Potato 5 kg, Tea leaves 100 gram Mask 3 pieces, Hand Sanitizer, Tooth brush and tooth paste were distributed. Hon'ble Sabhadhipati of Paschim Tripura Zila Parishad, Smt. Antara Deb Sarkar and Saha Sabhadhipati Sri Haridulal Acharjee were present in the programs. In total 153 elderly and divyangjan were benefitted through this program.

Awareness Cum Nutritional Kits Distribution under Jirania RD Block

Abhoy Mission in cooperation with Paschim Tripura Zilla Parishad organized an awareness program as well as program for support of nutritional and sanitization materials within the elderly people and persons with disabilities of the families which hit most by the 2nd Wave of Corona pandemic situation. The program was structured in Ramkrishna Mission Ashram of Mohanpur on 31st March, 2021. Nutritional materials and Sanitization kit were distributed among 20 Nos. of beneficiaries in the program.

"Developing Comprehensive Services and Infra- structure for Children & Adults with Deafblindness and Multisensory Impairment in NE" – Tripura

Through collaboration from Sense International India, ABHOY MISSION started project for Children & Adults with Deafblindness & Multisensory Impairment from the month of October, 2019. Capacity building and Empowerment of Children & Adults with involvement of Community Resources is the chief purpose of the project. At the initial part this year, 12 such children & adults were provided service through this project. Direct service of the project is being provided through i) training within the ambit & principle of special education ii) Assistive Device on the functional needs of a child iii) Coordination with different agencies with goal of taking benefit of different schemes iv) regular counseling & motivation. Indirect service is being provided to those individuals who cannot be brought under direct service. Indirect service is provided through i) synchronization with diverse agencies & ii) counseling & inspiration.

During the course of the project, this year, 06 new children has been identified but at the same time we lost one child beneficiary as she expired as a result of her ailing condition.

At the closing stage of year 2020-21, direct service is being provided to 15 children & adults.










State Level Training Program on Deafblindness

On 10th September, 2020, an online State level Training was organized involving SSA Teachers and others was organized through this project. 73 participants including 32 SSA Teachers, 09 paramedical professionals, 08 block resource persons and supervisors, 02 Inclusive Education Coordinators and 03 special educators participated in the training program. Srinivasan Played the role of Resource person in the program. He covered concept of Deafblindness, types of deafblind and communication for deafblind persons very nicely.





State Level Network Meeting

Tripura State Level Network Meeting through this project was organized on 24th & 25th August, 2020. Importance of such meeting & network formation was elucidated by Parag Namdeo & Shrutilata Singh. 07Parents & family members (01 male & 06 female) participated in the meeting. This is the first such meeting of parents & family members of persons with deafblindness in Tripura State. Parents & family members shared their experiences. The parents & family members realized the necessity & importance of such meeting and formation of network.

State Level Advocacy meeting

Tripura State Level Advocacy meeting was arranged on 26th August, 2020. Parag Namdeo & Shrutilata Singh was the faculty member in the meeting. Coordinator was Deepak Krishna Sharma. 07 Parents & family members (01 male & 06 female) joined the meeting. 01 male & 04 female family members shared their experiences. Besides parents & family members, Delegates from CRC Tripura, DDRC West Tripura, DDRC, Dhalai, National Career Service Centre, Agartala, Deputy Disability Commissioner for Disabilities, DISE, Sepahijala District participated in the program. Delegates from different agencies provided suggestion & advice towards resolving difficulties faced by the parents & family members.

Distribution of Aids and Appliances

In collaboration with the National Institute for Empowerment of Persons with Disabilities (NIEPMD), a camp for Distribution of Aids & Appliances among the persons with Disabilities, was organized in Sonamura Town Hall on 11th December, 2020. Smt. Niti Deb, renowned Social Worker as well as wife of Hon'ble Chief Minister of Tripura, graced the chair of Chief Guest in the program. Smt Supriya Das Datta, Hon'ble
